We develop standards, tools, and guidance that allow companies to set greenhouse gas (GHG) emissions reduction targets in line with what is needed to keep global heating below catastrophic levels and reach net zero by 2050 at the latest. The SBTi is incorporated as a UK charity, with a subsidiary SBTi Services Limited, which hosts our target validation services (together with SBTi, the "SBTi Group"). Your Role:

The SBTi is looking for a Compliance Manager to join the Compliance Team.

This is a full-time remote working role based in the UK or Germany. The salary for this role will be dependent on location and level of experience. This role is a fixed-term contract for 12 months with the possibility of extension. Interested candidates should be legally allowed to work in the countries specified.

The SBTi cannot sponsor any working visas.

Your Team:

You will be one of two Compliance Managers at the SBTi who work cross-departmentally and report directly to the SBTi Compliance Director.

Responsibilities

- Drafting and supporting the implementation of the SBTi Policies and procedures including training to the SBTi on Whistleblowing, Safeguarding, and Conflicts of Interest
- Developing internal control documents
- Establish formal monitoring systems for SBTi-wide implementation of compliance.
- Tracking, reviewing, and responding to complaints, allegations, and appeals, including ensuring incidents are actioned and documented appropriately
- Working cross-departmentally to respond to compliance issues and queries
- Conducting risk assessments and developing mitigation measures
- Reviewing regulatory changes to support the continued alignment of the SBTi
- Day-to-day management of the SBTi compliance system

- Minimum of 5 years experience in compliance, legal, and/ or certification
- Knowledge of the regulatory environment in which the SBTi operates
- Experience working for a formal voluntary standard-setting body
- Solid understanding of risk and compliance principles and frameworks
- Demonstrated experience responding to complaints, allegations, and appeals
- Experience performing organizational risk assessments
- Ability to use Google Drive and Microsoft Office Packages including Word, Excel, and PowerPoint to an intermediate level
