### **Job Purpose and Background:**

The Science Based Targets (SBTi) initiative is looking for a **Subject Matter Expert, Energy** to support the Sector Standards Team's work on the energy sectors.

As the SME, Energy, the position will focus in particular on supporting the development of the Power sector standard, but also the Oil & Gas standard and other energy-related questions and projects (such as bioenergy). Over time, the role will broaden its scope to cover energy and bioenergy questions across the Sector Standards Team.

**This position will report to the Energy Lead.**

### **This role plays an important part in achieving:**

The role is pivotal in the development of SBTi's sector-specific standards for several high-impact energy sectors, as well as keeping SBTi's existing resources and criteria up to date and providing guidance on these to other teams. In particular, the role will support the Power and O&G standard projects, future energy sector projects, and cross-overs between energy and other sectors.

**You are a great fit for this role if you:** are an energy and decarbonization expert, with the interest and flexibility to also work on other sectors, and are motivated to use science-based targets to make a real difference in decarbonizing these sectors. You have technical expertise in at least one heavy emitting or energy sector; experience in GHG accounting, and skills in managing multiple stakeholders.

The SBTi is a global body enabling businesses to set ambitious emissions reduction targets in line with the latest climate science. It is focused on accelerating companies worldwide to halve emissions before 2030 and achieve net-zero emissions before 2050.

The SBTi defines and promotes best practices in science-based target setting, offers resources and guidance to reduce barriers to adoption, and independently assesses and approves companies' targets.

### **Key responsibilities include:**

- Provides subject matter expertise to inform the development of SBTi's technical outputs, in particular for the energy and bioenergy sectors, such as standards, guidance explanatory documents, tools, etc.
- Collaborates with senior team members to draft, review, and finalize major outputs of the Technical Department in line with SBTi's Standard Operating Procedures.
- Monitors emerging trends, research, and policies relevant to the organization's work to

maintain cutting-edge expertise.

- Prepares technical material, e.g. presentations, webinars, and workshops to disseminate key findings and/or gather further input from internal and external stakeholders and delivers this material independently and/or in collaboration with the Lead
- Contributes to cross-departmental collaboration to maximize the impact and applicability of their work.
- Acts as day-to-day contact of external technical partners
- Supports other ad-hoc technical activities as required by the organization.
- Role model's respectful behavior, open communication, and integrity as vital pillars of SBTi's culture.

### **Essential skills and experience needed:**

- 7+ years of professional experience in the relevant field, demonstrating solid knowledge in standard-setting, GHG accounting, science-based target-setting, and decarbonization of the corporate sector.
- Strong track record of delivering assigned responsibilities on time and to high standards.
- Experience in standard writing, research, and data analysis, with the ability to synthesize complex information.
- Excellent written and verbal communication skills, including the ability to convey technical concepts to non-technical audiences.
- Proficiency in relevant tools and software required for the role to be successful.
- Solid technical/specialist knowledge of the energy sectors and bioenergy.

### **Desirable criteria:**

- Knowledge and willingness to work in other sectors, in particular, AFOLU (agriculture, forestry, and land use)
